Introduction

In accordance with SERB rules and regulations the undersigned Conciliator was appointed on December 24, 2012 to hear the case between IAFF Local 3544 and the Springfield Township Trustees. The parties agreed to hold a conciliation hearing on the above-matter on January 22, 2013. Both parties served their position statements to the Conciliator, SERB and to each other in a timely fashion prior to the hearing.

Mediation and Conciliation Award

Prior to the hearing, the Conciliator offered mediation for the single unresolved issue: 2013 wage rates for all bargaining unit members. The parties agreed to mediate and were able to reach the following agreement, which is hereby incorporated into the conciliator's award in this matter:

All dispatchers shall receive a 2.5% wage adjustment effective January 1, 2013. In addition all bargaining unit members, including dispatchers, shall receive a 2.0% general wage increase effective January 1, 2013. Finally, all bargaining unit members shall receive a \$200.00 lump sum payment upon issuance of this award as provided for with the following language:

ARTICLE 21 WAGES

~~21.7. Between September 1 and November 1, 2012, either party may, by written notice to the other, reopen negotiations for Article 21, Wages.~~


