DISCUSSION

The parties submitted language that they agreed upon and would resolve both issues. A paper copy of this language was submitted at the hearing and the parties authorized the Employer

to submit the language electronically. That language is submitted as Exhibit 1, Longevity and Wages and Exhibit 2, Employee Wellness. Both exhibits are attached hereto.

The undersigned received a copy of the fact-finding report, and the fact finding report was reviewed by this conciliator. During mediation, both parties met separately with the conciliator and both presented their respective positions. After meeting separately, the parties met together with this conciliator and at least one time without the conciliator.

This mediation process led to an agreement between the parties. The parties presented the language they agreed upon in Exhibit 1 and Exhibit 2.


The undersigned reviewed the fact finding report and the oral recommendations of the parties, along with the facts presented in mediation supporting their recommendation.
